# #18-259 A RESOLUTION DECLARING THAT AN URGENT NECESSITY EXISTS FOR ROOF REPAIRS AT THE ZANESVILLE HIGH SCHOOL ANNEX BUILDING

Mr. Coulson moved and Mr. Bunting seconded to approve the following resolution:

WHEREAS, Section 3313.46 of the Revised Code requires boards of education to advertise for bids for a period of two weeks when they determine to make certain improvements to school buildings, the cost of which will exceed \$50,000, and to award contracts to the lowest responsible bidders, except in cases of urgent necessity; and

WHEREAS, the District is performing certain facilities improvements including the repair of the roof at the Zanesville High School Annex Building; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Zanesville City School District, Muskingum County, Ohio, that:

- Section 1. <u>Finding of Urgent Necessity</u>. For the aforesaid reason, this Board hereby finds, determines and declares that an urgent necessity exists with respect to the commencement of the roof repair at the Zanesville High School Annex Building, that compliance with the relatively lengthy procedures prescribed by Section 3313.46 of the Revised Code could compromise the educational integrity and mission of the District, and that said Section 3313.46 does not apply to the contract approval in Section 2 herein.
- Section 2. <u>Approval of Contract</u>. The President or Vice-President and Treasurer of this Board and the Superintendent, each and all, are hereby authorized and directed to get quotes with Edwards Roofing as a design build project in order to meet project schedule and completion and to take all other actions necessary and appropriate to carry out the work in accordance with the intentions of this Board as expressed in this Resolution.
- Section 3. <u>Prior Acts Ratified and Confirmed.</u> Any actions previously taken by School District officials or agents of this Board in furtherance of the matters set forth in this Resolution are hereby approved, ratified and confirmed.

Services include tutoring, academic counseling, transition services, parental involvement activities, PD, special education services, 2 FTE licensed teachers provided through Zanesville City Schools, and equipment/materials. Funding will be with Title I Neglected and Delinquent funds for the FY 19 school year.

# #18-266 AGREEMENT BETWEEN ZANESVILLE CITY SCHOOLS AND EDMENTUM

- Education City and Reading Eggs building site licenses for John McIntire, National Road, and Zane Grey
- Study Island NWEA Integrated Solution elementary district site license
- One day onsite support and 6 hours virtual support per building per year for Education City and Reading Eggs
- One day onsite support per year for Study Island NWEA Integrated Solutions
- Renewal of three (3) school-based licenses to Edmentum for each of 3 years with a contingency opt-out clause in the event that funding from Dollar General is not secured beyond year one or year two.
