**#15-324            AGREEMENT BETWEEN ZANESVILLE CITY SCHOOLS AND THE BARBARA BUSH FOUNDATION FOR FAMILY LITERACY, INC.**

Mrs. Stewart moved and Mr. Swope seconded to enter into an agreement between Zanesville City Schools and The Barbara Bush Foundation for Family Literacy, Inc. for the purpose of implementing the Teen Trendsetters Reading Mentors program. Components include:

- Program sites at each of three elementary schools (John McIntire, National Road, and Zane Grey) at a cost of \$10,000 per site with one site at no cost through in-kind donation by BBF.
- Mentor training and materials.
- A \$1,000 stipend paid by BBF for a coordinator at each site along with programmatic and evaluation technical assistance.
- 9-14 books for each student to take home to reinforce a love for reading.

Term of license will be one year for the FY16 school year. Total project cost will be \$20,000. Funds have been secured through a Dollar General Literacy Project grant.

**#15-325            AGREEMENT BETWEEN ZANESVILLE CITY SCHOOLS AND EDMENTUM.**

Mr. Eppley moved and Mr. Bunting seconded to enter into an agreement between Zanesville City Schools and Edmentum for the purpose of providing electronic support for teachers and online learning for students for after-school programming. Components include:

- Education City and Reading Eggs building site licenses for John McIntire, National Road, and Zane Grey.
- Study Island NWEA Integrated Solution elementary district site license
- One day onsite support and 6 hours virtual support per building per year for Education City and Reading Eggs.
- One day onsite support per year for Study Island NWEA Integrated Solutions.
- Renewal of three (3) school-based licenses to Edmentum for each of 3 years with a contingency opt-out clause in the event that funding from Dollar General is not secured beyond year one or year two.

Term of license will be October 2015 through June 2018. Yearly project cost will be \$79,991.00 per year for a total three year project cost of 239,973.00. Funds have been secured through a Dollar General Literacy Project grant.
