#10-346 COURSE OF STUDY

Mrs. Stewart moved and Mr. Bunting seconded to approve the following course of student for Introduction to Robotics to begin second semester of the 2010-2011 school year.

**Course Guide
Introduction to Robotics
Zanesville City Schools
Submitted: October 25, 2010**

Preface: Introduction to Robotics is a one-semester elective course in science and technology. With increasing skill requirements for high school graduates, this course will serve as in in-depth, hands-on introduction to the use of robotic technology to accomplish specific tasks. Throughout the tem, students will build actual working robots of different types and learn how they are controlled. The students will work collaboratively so as to be an authentic work environment where project teams are the normal organizational structure.

This course will also provide a challenging course in the junior year that may motivate students to consider a career in STEM technologies and encourage them to take a more rigorous course load during the senior year.

The General Purpose and Outcome of the Course

This course is intended to provide an enjoyable but challenging introduction to the field of automation and robotics. Students will learn to work cooperatively in small groups to build specific applications of robots and will then be challenged to create their own full-class experience in designing and building a complex robot that will accomplish a complicated task by remote control.

Students will also be required to do independent research on an application of robotics in an area of interest (space exploration, production lines, surgical robotics, nanotechnology, etc.), utilize the Internet to find relevant information and develop a 5-7 page written technical report and produce a PowerPoint presentation for the entire class.

With technology continuing to expand, our students need to be well-versed in high-technology and its applications in our modern world.

The Learning Goals of the Course

Educational Goals:

- Provide a solid introduction to automation.
- Provide a hands-on technology group experience
- Motivate students to take advanced courses in the senior year
- Challenge the students to be creative problem-solvers
- Develop research skills through an individual project (report and presentation)
